GROUND REGULATIONS

Barrfields Park, Largs Thistle Football Club

Entry to Barrfields Park, whether on payment or otherwise, shall be deemed to constitute acceptance with the following Ground Regulations. Any failure to adhere to these Regulations may result in expulsion from Barrfields Park, a possible ban on attending future games at Barrfields Park, and possible action by Police Scotland, as appropriate.

Competition rules and matchday

1. All matches at Barrfields Park shall be played in accordance with the rules and regulations of the WOSFL and the SFA.
2. The Club reserves the right to change the time or date of its advertised matches without notice and without liability, or on advice/requirement of the WOSFL or SFA.
3. All persons attending a match at Barrfields Park shall pay the applicable admission charge, notified at the pay gates, unless otherwise authorised by the Club i.e., when in possession of a season ticket, a league-authorised Committee pass or an official media pass.

Prohibited actions and items at Barrfields Park

1. Be aware that the following items are not permitted in Barrfields:

- knives
- fireworks
- smoke canisters
- flares of other pyrotechnics
- air horns

- laser devices
- glass bottles
- poles

2. Smoking is not permitted anywhere in Barrfields Park. This includes the fan's cabin or the Legends Lounge, the toilets, by the canteen or in the covered stand.
3. Climbing on fences, barriers or other structures within Barrfields is strictly forbidden.
4. The use of audible devices (such as radio sets or whistles) which cause unnecessary or distracting noise is not permitted.
5. The unauthorised live transmission of any video images of a match is not permitted.
6. Supporters shall avoid obstructing entrances, exits and stairways. When leaving Barrfields Park, spectators must do so in an orderly manner.
7. The consumption of alcohol is permitted only when purchased in the fan's cabin or Legends Lounge, the latter as part of a hospitality package.

Responding to emergencies

1. In the event of an emergency incident, the Club will announce any required instructions over the Public Address (PA) System. Spectators must follow all such instructions and any further directions from Club stewards, the Safety Officer or officials, or from police officers.
2. If a match is abandoned during the course of the game, any refund of admission charges shall be at the sole discretion of the Club. Spectators are advised to retain their admission tickets pending any announcement by the Club.

Your rights

1. All persons entering Barrfields Park shall be deemed to consent to photographic and/or video images being taken of them. Such images may be used by the Club for safety, security, or promotional purposes. If any images feature an individual prominently, then the Club will make reasonable efforts to obtain the consent of the individual in advance before publishing such images for promotional reasons. If the individual is aged under eighteen, such consent will be sought from the appropriate parent, guardian or responsible adult.

Unacceptable conduct

1. Any infringement of our [Unacceptable Conduct Policy](#) may result in immediate expulsion from Barrfields Park and potential action by Police Scotland. Unacceptable conduct includes –
 - violent or disorderly conduct
 - the use of foul or abusive language
 - racist, discriminatory or sectarian remarks, chants or songs
 - promotion of any political or banned organisation
 - throwing objects onto the field of play or at other persons
 - damaging or defacing any Club property
 - any other act which is deemed by the Club to be a danger, nuisance or annoyance to players, officials or spectators

Spectators are not authorised to enter the field of play except in emergencies or when authorised by match officials.

If you see anything happening which breaches these Regulations, please report it to Club officials, or the Safety Officer, as soon as possible.
